



Legal Basis, Acceptance of Terms and Conditions

Dear User:

Through this option, you may **VOLUNTARILY and FREE OF CHARGE** request your registration in the Single Taxpayer Registry (RUC) in order to obtain your NIT card digitally. This is in accordance with the provisions of Articles 1 and 4 of the Law on the Registry and Special Control of Taxpayers to the Treasury. Therefore, before starting your online application, you must take into account the following:

1. To initiate your process, the documents requested must be valid.
2. According to Article 288 of the Penal Code of El Salvador, the identity document must not belong to another person in order to avoid committing a crime by the false use thereof.
3. According to Articles 7 and 13 of the Law on the Name of Natural Persons, the NIT will be issued with the legal name and not the "known as" name.
4. The account management is the sole responsibility of the user; therefore, in case of non-compliance with the provisions set forth herein or misuse of the account, the user will be subject to the corresponding administrative and criminal actions by the competent authorities.






